(vi) Srivastava MRI & Imaging Centre, Mayur Vihar, New Delhi. (vii) Mahavir International, Hauz Rani Market, New Delhi were empanelled under CGHS Delhi/ NCR and to state that as per terms and conditions of empanelment all Non-NABH/ Non-NABL health Care Organizations were to get themselves inspected and recommended by QCI within one year of empanelment for continuation of their empanelment with CGHS.
