Consequent upon implementation of recommendations of 6th CPC as accepted by Govt. of India, instructions regarding placement and fixation of pay of Group 'D' employees (other than RPF/ RPSF) in Grade pay of Rs. 1800/- in PB-1 (Rs. 5200-20200) were issued vide Board's letter of even number dated 29.10.2008 (RBE No. 160/2008). Further clarification/ instructions on the issue were issued vide Board's letters of even number dated 12.01.2009 & 08.11.2010.

- 2. On the basis of various references received from Zonal Railways and an Item being raised by NFIR on the issue; the matter has been further examined in consultation with the Ministry of Finance keeping in view the stipulation contained in Note 1 under Rule 7 (1) of Railway Service (Revised Pay) Rules, 2008 and it has been decided that those non-matriculate/ non-ITI Group 'D' employees, who were in service on the date of notification of Railway Service (Revised Pay) Rules, 2008 and retired/ expired or left service within six months of the notification of the Railway Services (Revised Pay) Rules, without being imparted training due to administrative reasons, may be placed in PB-1 with Grade Pay Rs. 1800/-
- 3. This issues with the concurrence of Finance Directorate of this Ministry.

विषय: मौजूदा ग्रुप 'डी' कर्मचारियों का संशोधित वेतन संरचना में वेतन निर्धारित करने के संबंध में स्पष्टीकरण।

भारत सरकार द्वारा यथा स्वीकृत छठे केन्द्रीय वेतन आयोग की सिफारिशों के क्रियान्वयन के परिणामस्वरूप बोर्ड के दिनांक 29.10.2008 के समसंख्यक पत्र (आरबीई सं. 160/2008) के तहत, पीबी-। (5200-20200 रुपए), ग्रेड पे 1800/- रुपए में ग्रुप 'डी' कर्मचारियों (आरपीएफ/आरपीएसएफ को छोड़कर) को रखने और उनका वेतन निर्धारित करने से संबंधित अनुदेश जारी किए गए थे। बोर्ड के दिनांक 12.01.2009 एवं 08.11.2010 के समसंख्यक पत्रों के तहत इस मामले में आगे स्पष्टीकरण/अनुदेश जारी किए गए थे।

- 2. क्षेत्रीय रेलों से प्राप्त विभिन्न संदर्भों और इस मामले में एनएफआईआर द्वारा उठाए गए मुद्दे के आधार पर रेल सेवा (संशोधित वेतन) नियम, 2008 के नियम 7(1) के नोट 1 में निहित शर्त को ध्यान में रखते हुए वित्त मंत्रालय के परामर्श से इस मामले की जांच की गई है और यह विनिश्चय किया गया है कि ऐसे गैर-दसवीं पास/गैर-आईटीआई ग्रुप 'डी' कर्मचारी, जो रेल सेवा (संशोधित वेतन) नियम, 2008 की अधिसूचना के जारी होने की तारीख को सेवा में थे और जो प्रशासनिक कारणों से प्रशिक्षण प्राप्त किए बिना रेल सेवा (संशोधित वेतन) नियम की अधिसूचना के छः माह के भीतर सेवानिवृत्त हो गए थे/उनकी मृत्यु हो गई अथवा जिन्होंने सेवा छोड़ दी, उन्हें ग्रेड पे 1800/- रुपए के साथ पीबी-1 में रखा जाए।
- 3. इसे इस मंत्रालय के वित्त निदेशालय की सहमति से जारी किया जाता है।
